

There's a Reason Why So Many Oppose Privatization

Undercover sting operations in New York City makes it plain why so many public health, safety and faith-based groups oppose privatizing the PLCB: it puts kids at risk. Consider:

"Under-age decoy buyers were able to purchase alcohol at more than half of the hundreds of pharmacies, grocery stores and liquor stores in New York City that the State Liquor Authority targeted in an undercover investigation last year," *The New York Times*, May 3, 2015.

"Investigators caught hundreds of city stores selling booze to underage kids, officials said. The State Liquor Authority sent decoys who were under 21 to 911 grocery stores, pharmacies and liquor stores across the five boroughs — and 58% of them sold alcohol to the underage investigators," *The New York Daily News*, May 3, 2015.
