s we near the Democratic Presidential Primary, I am writing to formally announce the UFCW Local 1776 Executive Board endorsement of Hillary Clinton for President.

At our Local, we take every candidate endorsement very seriously. We follow the same protocol with each and every

endorsement we make, studying the records and experience of candidates and polling our Executive Board on who deserves our backing. Given the prominence of this year's Presidential Election, we seriously considered what our endorsement would mean for the working people that make up our Union and furthermore, how our endorsement would shape the General Election in November.

In January, after a nearly year-long polling process of UFCW members all across the country, the UFCW International Union endorsed Hillary Clinton. This past week, our Executive Board came to a nearly unanimous decision to endorse Hillary Clinton. Here's why:

Hillary Clinton's experience is unmatched. She is

the only candidate, on either side of the aisle. who is well versed in every issue we care about AND knows what it will take to get the job done. While Senator Bernie Sanders is certainly passionate about many of the issues that are near and dear to working families, Hillary's plan of action is a more practical and feasible one. Hillary is a dreamer and a doer and her track record spoke at the Pennsylvania

AFL-CIO Constitutional Convention. She touched on issues like minimum wage, the importance of having a

Union, paid leave, and keeping good jobs while creating new ones right here at home.

Our endorsement holds more value than the Primary Election alone. When making our endorsement, we had to think ahead to the General Election and greatly consider which candidate would most likely defeat the extreme Right-wing nominee. It's clear this year's election will be decided by moderate voters of both parties and independents. If Bernie were chosen as the Democratic nominee, he would be seen as too liberal to be elected as President – NOT by OUR standards, but by the voters who will ultimately make the decision. Moderate Republicans and independent voters will vote for Donald Trump or Ted Cruz before Bernie Sanders. It is true in many ways Bernie has been unfairly painted as too liberal. Fair or not, our Executive Board recognizes the unlikelihood he will be able to garnish enough votes for victory in November. We need to field the candidate that not only says everything we like in the best way, but also has the best chance of winning.

Strip away the rhetoric and you will see Bernie and Hillary are almost exactly the same on issues that matter most to working people. As U.S. Senators, their voting record was more than 90 percent identical.

Hillary will work to safeguard the rights you have as Union members and lift the middle class as a whole.

Let me be clear: our endorsement of Hillary Clinton was very much a pragmatic decision; but most definitely not a compromise. Our decision was based on Hillary's track record, knowledge and her plan for the middle class. I am fully confident she is the best candidate for working

people across the nation and I ask that you support her in the Democratic Primary on April 26th.

DWIGHT EVANS, DEMOCRAT FOR U.S. HOUSE OF REPRESENTATIVES, 2ND DISTRICT

He also helped issue the first marriage licenses to LGBT couples in Pennsylvania. Josh has met with UFCW members on numerous occasions and proudly supports the rights of working people.
